

1- Provision, authorization or approval credential provided for more than three months from issuance for the bids submitted without the name of authorized manager.

2- Purchase receipt of original bid documents.

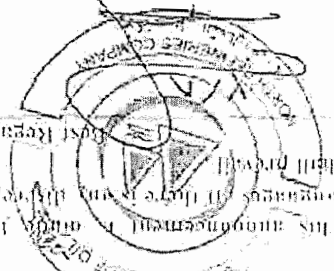
