ب pursuant to the publication of the tender notice in the Al-Furat Al-Bab newspaper and the Ministry of Industry and Minerals website, the tenders will be submitted in three closed, separate and sealed envelopes (technical offer, commercial offer and documents) marked with the bidder's name and address, tender number, subject of tender, closing date and time.

The bidder should submit an official letter authorizing the person who delivered the offer to send the offers by express mail or registered mail in such a way to ensure its arrival to our company before the closing date as well as inform us by e-mail the number of shipment (air way bill) which contains the offer in order to follow up receiving it before closing date. The offers received after closing date and sent by e-mail are not accepted. The offer should include attaching the bid bond otherwise it shall be neglected. The bid bond should be submitted from the bidder or any of share holders in the company or partners companies by joint venture contract approved officially including referring to the number and name of tender. The bid bond should be issued by non-conditional approved bank guarantee valid for (4) four months at least or confirmed cheque or bill of exchange through accredited bank in accordance with the instructions issued by central bank of Iraq as well as submit the identical works. The validity of offers should be (3) three months from closing date. The prices are final and non-negotiable. Our company is not bind to accept the lowest offers. The bidder should submit his offer according to the standard documents requirements. and not obligating of bidder with all sections of standard documents requirements will lead to reject his bid.
