1-The **General Company for Grain Processing** is pleased to announce for the first time a tender for (supplying (777) seven hundred seventy seven tons of premix material.

2- The **General Company for Grain Processing** has the financial allocations within the (ration card allocations / Ministry of Finance) and intends to use part of it to implement the supplying of the premix material.

3-Bidders who wish to buy tender documents in the (Arabic) language can submit a written request to the (**General Company for Grain Processing / Legal Department**) after paying a value for the non-refundable documents amounting to (1,000,000) million dinars according to an instrument certified by a government bank, Bidders/who wish to have more information can contact the address below.

4- Receive the bids to the following address (**General Company for Grain Processing / Office of the General Manager** located in Baghdad Governorate / Aden Square / Entrance to Al-Hurriya City) on the specified date (maximum at (10 :00) a.m on day 24/11/2020 according to Baghdad timing) . The late bids will be rejected and bids will be opened in the presence of the bidders or their representatives who wish to attend at the same time, date and address.

((All texts mentioned in Instructions for Implementing Government Contracts No. 2 of 2014 shall be applied in all that is not mentioned in this announcement or contradicts with it in content))

Bids must include the following: -

1- Establishment certification of the company submitting the tender with a clearance of the renewal fees at the Companies Registrar Department, even if the company is an organization outside the country that is approved by) Iraqi embassy, consulate or attaché in the country of incorporation.

2- Initial insurance is presented with a certified instrument or performance bond in the amount of (89545365) eighty-nine million five hundred forty-five thousand three hundred sixty-five dinars at a rate of 3% of the estimated cost from one of the approved banks and an editor of the company's order exclusively by the bidder or Or whoever is authorized by law (35) The day of the bid validity date.

3- No objection letter from entering into tenders from the General Authority for Taxes for the year 2020 and addressed to the **General Company for Grain Processing** exclusively (the tenderer should committee to bring clearance book when getting contract).

4- Receipt of the tender terms.


5- Providing similar works.
