The Required Documents: -

- Documents submitted must be certified by the Ministry of Foreign Affairs and the Iraqi Embassy in the supplier, in case of submission of tenders by the agent companies, so the authorization must be a representative company certified by the Iraqi Embassy in the country of factory for 2019 and the representative company has to provide support of his authorization to purchase documents of the bid.
- Submit an initial deposit amount with the same name of the bidder or his agent, or an official authorization that no more than three months after the issuance of documents in the form of a certified magnetic guarantee issued by one of the banks approved by Central Bank of Iraq and Ministry of Oil, except referred with our bid documents.
- Procurement, authorization or approved credential provided no more than three months from issuance submitted without the name of authorized manager.
- Purchase receipt of original bid documents.

- 4- The certificate of origin must be authenticated by the competent Iraqi authorities in the country of origin.
- 5- The goods shall be subject to inspection by inspection company (Tuv Rheinland , Bureau Veritas , ATG, Lloyds Register, Intertek Global).
- 6- Financial dues are paid according to announced payment method.
- 7- The contract is subject to tax and all legal fees and the law of collection of governmental debt N according to Iraqi laws in force.
- 8- The commercial agencies must be national for Iraqi companies registered in Iraq according to Iraqi laws.
- 9- The bidding process shall be conducted, studied and analyzed in accordance with the provisions of government contracts No.2 of 2014, the regulations attached thereto and the Criteria the qualify for bidding.
- 10- The contract winner shall be required to submit a performance bond guarantee at a rate of 5% of the contract value before signing the contract in the form of letter of guarantee issued by a government bank or any bank approved by the Central Bank of Iraq and the Ministry of Oil except of the banks referred to in the tender document.
- 11- The bidder must confirm his name, commercial address, exact residence address, telephone number and e-mail address, in a precise and clear manner, with a copy of his personal documents.
- 12- The company is not obliged to accept lower bids.
- 13- Packing of the contracted materials shall be in accordance with the approved specifications of packing and the bidder shall bear all damages to the materials due to the transport or packing process.
- 14- The security situation in Iraq is not considered a reason to avoid contractual obligations and must be taken into consideration in order to extend the duration of the contract.
- 15- The amount of the bid shall be deemed irrevocable and shall not be negotiated.
- 16- The bidder shall comply with the conditions required in the specification table, special conditions and other criteria.
- 17- The delay penalties shall be calculated according to equation mentioned in paragraph 32 of the specification. The maximum range of penalties shall be determined before signing of the contract.
- 18- Any applications relating to changing specifications, origins, or numbers after signing the contract shall not be accepted.
- 19- The committee (Tender Study and Analysis Committee) shall have the right to disregard any bid errors in the price, the write -off, the corrections or the amendments, even if the bidder has low competition.
- 20- The participation in buying tender shall be done during all the days of the week (Official Working Hours) from 8 o'clock in the afternoon, except the public holidays.
- 21- The final dues payment shall not be settled until a clearance has been submitted by the General Authority for the Procurement of the Refineries Company.
- 22- The bid should be valid for 120 days from the closing date, the requisition and any reservation shall be valid for the same period.
- 23- All participants in the bid or their representatives can attend the opening meeting bids, at the Refineries Company in the province of Salah al-Din / Baiji at (ten o'clock) of the day following the closing date.
- 24- Our company has the right to cancel the above bid at any stage without bearing any legal consequences.
- 25- Our company has the right to extend the closing date of the bid above if there are any required reasons.
- 26- All participators should be view the standard conditions then stamp it and attached with the submitted bid.
