

- 11.. Iraqi bidders and foreign companies ,that have branch or representation bureau in Iraq shall submit a no - objection letter to participate in tenders issued by the General Taxes authority addressed to the ministry of defense with confirmation of granting tax identity & submit tax clearance
- 12. First party has the right to confiscate the bid bond of the winner when retract to sign contract after being notified of awarding or when bidders withdraw within the offer validity after the tender closing date or refuse to correct prices errors in offers and their consequences on awarding, there will be legal measurements stated in governmental
