Foreseen construction period is 15 months.

The Ministry of Construction, Housing, Municipalities and Public Works (MoCHMPW) has received financing from KfW within the frame of the "German Credit Facility to assist the Return of IDP's in Iraq (GCFI)". The fund includes the rehabilitation of Mosul - Al-Qayara Junction - Ramadhanyat Road in Nineveh Governorate, Iraq (Lot 1&2). The works will be procured in 2 lots:

Lot 1: Construction Works for the Rehabilitation of Part (A), Mosul - Al-Qayara Junction (51km)

Lot 2: Construction Works for the Rehabilitation of Part (B), Al-Qayara Junction - Ramadhanyat (43.8km)

Lot 2 includes main services to rehabilitate 39 km of Part (B) and optional services to rehabilitate further 4.8 km of Part (B) of the road. Bidders shall price both, the main and the optional services. The financial proposal will be evaluated on the total sum. The Employer reserves his right to exclude, partially or fully include the optional services in the works contract.

Further rehabilitation activities for several bridges in the Nineveh Governorate will be tendered as well under the "Quick Wins Project Roads and Bridges". MoCHMPW now invites for sealed bids from eligible bidders for the implementation of rehabilitation works.

The Mosul - Al-Qayara Junction - Ramadhanyat Road is the 94.8 km long northern part of Mosul-Baghdad principal road within Nineveh Governorate. It was partially destroyed and requires surveys and design works as well as repair, cleaning and rehabilitation works to restore the traffic. The rehabilitation works of each lot shall be completed within 12 months in total including i.e. the following tasks:

- Milling, removal and disposal the existing damaged asphalt layers (e.g. light rutting, bleeding, corrugation, deep rutting, alligator cracks) after having surveyed and determined the treatment method of damages.
- Construction and repair of stabilized shoulders including clearing and levelling the existing shoulder, side slope and median, filling all slots and erosion areas with suitable fill material.
- Construction of pipe culverts and concrete manholes incl. removal of existing damaged structures.
- Clearing and removal of sediments, debris, rubble and unsuitable materials from the entire road site and all culvert inlets and outlets to restore their function.
- Laying asphalt concrete binder and wearing course on selected road sections incl. levelling and compaction of existing subbase layers.
- Construct & erect single guardrails, warning and regulatory signs and removing of existing damaged guardrails as well as new road marking for both carriageways.
- Construction of temporary detour.
