**REQUEST FOR EXPRESSION OF INTEREST**

The Government of Iraq (GOI) has received additional financing of an amount of US \$(400) four hundred million Dollars from the World Bank toward the cost of the Emergency Operation for Development Project (EODP-AF), and intends to apply part of the proceeds for **Construction Supervision for Kirkuk projects (Two Bridges and one Road)**. The project includes 3 sub-projects as following:

(1) **Kirkuk-Manzalah- road**, the rehabilitation works includes, but not limited to; i) treatment of the present distresses in the road and(ii); overlaying the entire length 32.11 km of the road surface with 5 cm hot- mix asphalt concrete wearing course (A/C) layer; (iii) reconstruction for AL-Rai 2nd Bridge; (iv) reconstruction of AL-Rai 3rd Bridge. The rehabilitation period is twelve (12) months.

(2) **Maktab Khalid Bridge**, the rehabilitation works includes, but not limited to;

a- demolition and removing all parts of superstructure for spans (S1, S2) including (Deck slab, asphalt wearing, sidewalk damaged girder, etc.); b-demolition and removing of all parts of Abutment (A1), pier (1) and piles after doing the structural evaluation and Integrity test for piles; c-placement of reinforced concrete Type (D20) for piles of (1.20m) Dim. for (Pier p1, and Abutment A1), pile cap pier (P1): Cross beam and column, Abutment (A1); d-placement of reinforced elastomeric bearings, Providing and transportation and placement of reinforced concrete girders (pre cast pre stress) length (20 m) and depth (1.2 m); e-placement of reinforced concrete for deck slab and diaphragm, sidewalks; and, f-spreading asphalt wearing course, set the expansion joint, installation of (hand rail, lighting pole) and operation lighting for bridge. The rehabilitation period is (8) months.

(3) **Rehabilitation Sadar Al-Nahr Bridge**, the rehabilitation works includes, but limited to;

a-demolition and removing all parts of superstructure for spans (S2, S3, S4, S5, S8, S9) including (Deck slab, asphalt wearing, sidewalk, girder, etc.); b-demolition and removing the piers (2,3,4, others if needed), intermediate pier and piles after doing the structural evaluation and Integrity test for piles; c-placement of reinforced concrete Type (D20) for piles of (1.20m) Dim. for piers if needed), and placement of reinforced concrete Abutment (A1, A2); d-placement of reinforced elastomeric bearings, Providing and transportation and placement of reinforced concrete girders (pre cast pre stress) length (20 m) and depth (0.85m); e-placement of reinforced concrete for deck slab and diaphragm, sidewalks; and, f-spreading of asphalt wearing course, setting the expansion joints, installation of (hand rail, lighting pole) and operation lighting for bridge. The rehabilitation period is (10) months.

The Project Employer is Roads and Bridges Directorate at the Ministry of Construction and Housing and Municipalities and Public Works.

The main objective of the assignment is to undertake supervision of rehabilitation works of the three projects, prepare final construction reports and review, approve full set of as-built drawings of all completed works to ensure compliance with the design, internationally acceptable technical specifications, environmental and social safeguards and sound engineering practices.
